## GIMLI FILM FESTIVAL (GFF) SUBMISSION RELEASE FORM

By submitting my proposal and related materials (the 'Material') to Gimli Film Festival, I hereby acknowledge, represent, warrant and agree as follows:

1. The Material is original, not copied in whole or in part from any other work, and does not infringe upon any third party's copyright, moral rights, publicity rights, or any other rights or defame any person. No other persons other than as indicated by me have collaborated with me in creating and developing the Material. If any other person has collaborated with me in creating and developing Material, he/she must execute the release or he/she will be deemed to have read and agreed with the terms and conditions of the Release.
2. GFF's consideration of the Material and any negotiations between us, regarding the Material will not be deemed an admission by GFF of the novelty or originality of the Material.
3. GFF may retain a copy of the Material. GFF is under no obligation to use the Material nor is GFF obligated to return the Material to me.
4. I hereby grant GFF the right to use the Material provided the GFF shall first conclude an agreement with me prior to GFF exercising its right, unless GFF determines that it has an independent legal right to use the Material or any portion thereof which is not derived from me either because the Material is not new, novel or original or has not been reduced to concrete form or because other persons (which may include GFF employees and other persons submitting materials to GFF) have submitted similar or identical ideas, suggestions, stories and other material which GFF has the right to use.
5. GFF receives numerous submissions of ideas, stories and other material from other sources and GFF creates and/or commissions others to create on GFF's behalf such materials. The subject matter, substance and/or other elements contained in such materials may be similar to those contained in the Material. I understand and acknowledge that GFF may have or will have other materials, which may have elements that are substantially similar to those, found in the Material.

I hereby, release and discharge GFF, its parent, subsidiaries, affiliated and associated companies and their directors, officers, agents, contractors, licensees, successors and assigns of and from any and all claims, demands, actions, liabilities and judgments whatsoever in law or equity, that I may now or hereafter have arising directly or indirectly out of any use of the Material.
7. The laws of Manitoba and the laws of Canada applicable will govern this release therein. Any dispute will be settled in the City of Winnipeg. This release constitutes our entire understanding concerning the Material, and my submission of the Material constitutes my agreement with the terms of this Release. This Release also applies to other materials, which I may submit to GFF unless it is agreed by us in writing to the contrary. The invalidity of any provision of this Release shall not affect the remainder, which shall continue in full force and effect.
